People with skills that will help to build a strong Unified World Pickleball Federation that will be able to work with the IOC and other sporting bodies at local, continental and world level.

While the current WPF Bylaws do not explicitly require a nominee to be a citizen or resident of a Member Country, it is expected – consistent with good governance practices and international norms – that nominees have a demonstrable and substantive relationship with the Member Organisation or that the Member Organisation does not veto the nominee. This may include:

- -Citizenship
- -Legal residence
- -Current or former leadership role within the Member Organisation
- -Long-term involvement or service

This ensures fair representation and alignment with the principles of accountability and international diversity.
