While the current WPF Bylaws do not explicitly require a nominee to be a citizen or resident of the nominating country, it is expected – consistent with good governance practices and international norms – that nominees have a demonstrable and substantive relationship with the National Federation that nominates them. This may include:

- -Citizenship
- -Legal residence
- -Current or former leadership role within the Federation
- -Long-term involvement or service

This ensures fair representation and alignment with the principles of accountability and international diversity.
